*Faculty domain leadership in leadership values and ethics.* Designed, developed, and continue to teach a Carey Business School signature course, *Business Leadership and Human Values*, to enhance the ethical capabilities of emerging and aspiring business leaders in situations of risk, uncertainty, and ambiguity for which quantitative, analytical skills are insufficient for robust decision-making. Actively involved in national and international academic and professional business ethics societies and regularly present work in conference venues. My current project with the Society for Business Ethics is working with three international colleagues to plan a plenary session and research workshop on gender equity, intersectionality, and social inclusion for the 2019 annual conference that will include our comprehensive 20-year critical review and analysis of gender and intersectional equity in business ethics literature.

**Faculty domain leadership in urban revitalization.** Founder and faculty director of CityLabs USA, an urban social impact business innovation collaborative focused on livable neighborhoods: Sustainable habitat, healthy people, cohesive communities, engaged citizens, and inclusive prosperity. Anchored in transitional urban neighborhoods in Baltimore, Washington DC, and other cities, CityLabs USA is a network of university students, alumni, and faculty working in cities to restore entrepreneurial business cultures, incubate new businesses, and create socially-purposed wealth that transforms struggling neighborhoods by reconnecting them to the mainstream economy through business ventures in real estate and infrastructure, innovative, technology-integrated finance, materials design and production, healthcare, and human services, lifestyle enhancement, and hospitality. CityLab courses and projects are cross-listed in the Carey Business School and Bloomberg School of Public Health. Urban domain expertise includes service on the Executive Committee of the Johns Hopkins 21<sup>st</sup> Century Cities Initiative promoting socially engaged, interdisciplinary research addressing urgent urbanization challenges. Actively involved in local, national, and international urban development initiatives including the DC Metro Collaborative to develop and promote normative models and metrics for social equity and inclusion in urban placemaking. CityLab projects involve development of extensive local and regional multi-sector networks including Brookings, Georgetown University, George Washington University, and Morgan State University to conduct joint CityLab and Real Estate Capstone neighborhood revitalization initiatives in Baltimore City and Washington DC. My academic and applied work in urban revitalization is nationally and internationally recognized among academic business ethicists.

**Faculty domain leadership in health policy.** Designed, developed, and direct the health policy course sequence in the MS program in Healthcare Management. Health policy domain leadership includes collaboration with the Johns Hopkins Bloomberg School of Public Health and School of Nursing colleagues in the Bloomberg American Health Initiative, the Culture of Ethical Practice in Healthcare Project, and various Urban Health Institute projects.

**Research agenda.** My research draws from social disparities, human capabilities, neurosciences, constructivist, philosophical, and critical theories in a holistic, multidimensional approach to understanding and fostering human wellbeing. Current/recent JHU research collaborators include: 1) Cynda Rushton, JHU School of Nursing professor, exploring workplace moral stress and resilience; 2) Mary Miller, JHU 21<sup>st</sup> Century Cities senior research fellow, analyzing economic and racial geographies of small business financing in Baltimore; 4) Brookings Institution, George Washington University, and JHU colleagues exploring alternative real estate financing models creating ladders to equity for low income, small business, and small nonprofit stakeholders in gentrifying communities; and 5) Elizabeth Talbert, JHU scholar (PhD, 2018), documenting the local and statewide economic impact of insufficient childcare in Maryland.

**Teaching and advising.** Current 21-credit annual teaching load (11 courses in an academic year of five eight-week terms) includes *Business Leadership and Human Values*, *Health Policy Design and Implementation*, *CityLabs*, and *the Real Estate and Infrastructure Capstone*. Advising includes doctoral candidates from other Johns Hopkins schools. Past teaching includes social enterprise and innovation, organizational behavior, global strategy, and a number of innovative international and domestic business lab courses as well as occasional courses in Classics at the Krieger School. I specialize in active learning laboratory formats focused on goal-oriented discovery, self-management, and collaborative leadership in response to disruption and adaptive challenges. I am actively involved in coaching and advising cross-disciplinary JHU graduate student business consulting teams working with JHU Social Innovation Lab clients. Since 2017 I have developed two online courses and expect to refine these courses, integrate them more deeply with onsite learning experiences, and develop new courses in the coming years.

**Faculty and program development.** I am currently collaborating with Carey and Johns Hopkins faculty and staff colleagues to develop a university-wide urban innovation certificate program and a center for active, experiential, and engaged learning at the Carey Business School. In addition to clarifying its mission, scope,

defining features, my specific role is to develop new approaches and tools for course design and evaluation as well as for developing faculty expertise in diverse modes of teaching and learning.

**School and University service leadership.** Actively engaged in mentoring and development of new faculty as well as developing and implementing a university-wide faculty mentoring and career development initiatives. Currently serve on the Johns Hopkins University 21<sup>st</sup> Century Cities Steering Committee to focus on urban economic revitalization and collaborating with School of Nursing colleague, Cynda Rushton, to develop an initiative to foster communities of ethical practice in healthcare and other service industries. Past service includes 1) Urban Health Institute as Co-Chair of the Community-University Collaborative Committee; 2) Provost Committee on Academic Freedom and the Faculty Mentoring Initiative; 3) Carey Admissions Committee; 4) JHU faculty mentoring and leadership development initiative; 5) Vice-Dean and faculty search committees; 6) Social Innovation Lab Task Force; 7) JHU President's Committee on Women; and 8) numerous Carey committees and initiatives to promote academic integrity and gender equity, enhance international student readiness for US graduate business study, promote faculty collegiality and governance structures, create venues to develop and showcase faculty and student talent, mentor students and alumni, develop new programs, and develop models and metrics for curriculum and instruction improvement.

- **Academic quality improvement.** Designed and implemented a vision and mission statement to anchor an academic quality improvement process that identified five key priorities: 1) Establish outcomes-based academic quality benchmarks for all programs; 2) Identify and correct academic deficiencies; 3) Raise the visibility of specialized high-value programs (Healthcare MBA, MSF, MS in Real Estate); 4) Develop a core of AACSB academically qualified full time and adjunct faculty; and 5) Develop an institutional infrastructure to support these priorities.
- **Academic program support.** Designed, developed, and managed the academic affairs infrastructure to align with strategic priorities. Specific achievements included the establishment of written policies, procedures, and protocols for academic discipline; academic program development, review, and revision; and faculty recruitment, development, review, and compensation.
