PAPER SUBMISSIONS

We invite completed paper submissions in all areas of finance, particularly early-stage papers that would benefit from presentation and discussion. We especially welcome papers in the following areas:

- Asset pricing models using natural language, AI, and ML.
- Climate finance and risks. Green, impact, investing and disclosure.
- Financial intermediation. Disruptions such as FinTech, RoboAdvising.
- International finance. Safe assets, the dollar factor, and yield curve control.
- Macro-finance. Inflation and labor market risks.
- Market microstructure. Algorithmic trading, AMMs.

Papers by current doctoral students without faculty coauthors will also be considered for a special poster session on Thursday, October 26. Students interested in consideration for these sessions should mark their submissions appropriately.

We plan to select up to 10 papers for the conference, including the poster session. Recent editions' programs can be found here: [2021](#) and [2022](#).
